Statewide Issues

There are five statewide issues on the ballot this year. Issue number four was withdrawn by committee in September so they are numbered 1, 2, 3, 5 and 6.

These issues are all proposed amendments to the State of Ohio Constitution which is currently 72 pages long. Our view on these amendments is really pretty simple keep the Constitution at its current length and vote "no" on all these issues

State Issue 1 proposes an earlier filing deadline. State Issue 2 authorizes the state to issue bonds to continue the Clean Ohio Program for environmental revitalization and conservation. State Issue 3 amends the constitution to protect private property rights in ground water, lakes and other watercourses.

Changing the deadlines does not guarantee that there will still be enough time to print corrected ballot - it's pretty much of a guess.

As for Issue 2, the authority to issue the bonds is not time-limited and publicly funded bonds may be utilized to benefit private entities

Issue 3 asks the voters to approve something that is already contained in Ohio case law. Therefore there is no reason to amend the constitution since property owners' rights are already protected in such circumstances

Let's turn our attention to the two big ticket items on the ballot.

Issue 5 proposes making changes to payday lending practices. A noble idea

A yes vote caps the annual interest rate on payday loans at 28 percent. Such lenders can currently charge up to 391 percent annually.

The problem with this amendment is that it represents the worst in government interference in private matters - nanny government run amok.

From a business standpoint, this is an amendment that will limit profits, that will force jobs to be lost, that will force businesses to be closed. This is certainly not a time for Ohio to become more anti-business than it already is.

From a private citizen's standpoint, this amendment will limit borrowers' choices, especially when there is a pressing need. The amendment further restricts the number of times someone may seek such loans each year.

Such loans are certainly usurious, but so are bank overdraft fees and credit card late fees.

Issue 6 is the casino amendment asking voters to approve the construction of one casino by a particular out-of-state casino operator on the Ohio River.

We aren't taking any view on in-state gambling in general, we just don't like this particular proposal because of the out-of-state component, the single casino component and the fact that the location is fixed in the southern part of the state.

When another casino is proposed, we will need another such amendment. There is a much easier way to introduce gambling to Ohio, if voters want it introduced at

Local Issues

Issues 34 to 41 are local levies. Issue 34 is a renewal levy for Toledo Public Schools for the purpose of providing for emergency requirements. It is a 4.8 mill levy for a period of 10 years. It is not a new tax and should be renewed. Vote "Yes" on Issue

Issue 35 is also a TPS levy that reauthorizes the bond passed in 2002 to finish the school building and renovation projects. It will not cost voters any more than it when it was originally approved in 2002. Vote "Yes" on Issue 35.

Issue 37 is the Center of Science and Industry (COSI) levy that is an additional tax in order to re-open the facility at a rate of 0.17 mill. That rate is a minimal investment for the re-opening of a facility that measurably improves the quality of life for Toledoarea residents and visitors. It enlivens the downtown area, increasing business for other merchants, hotels and restaurants. We missed an opportunity to keep COSI open in the spring primary, let's not miss another such chance. Vote "Yes" on Issue

Issue 38 is the Lucas County Children Services replacement levy in order to support the efforts of that agency in providing for the care and placement of children. Folks, this is a no brainer. LCCS can not continue to provide the level of services for abused, neglected and abandoned children without the funds to operate. Please, please, please vote "Yes" on Issue 38.

Issue 39 is a replacement tax for the Lucas County Mental Retardation/Developmental Disabilities Department. It will continue to provide financial support for the programs and services for disabled individuals and the operations of the facilities. Vote "Yes" on Issue 39.

Issue 40 is a replacement tax for the Lucas County Mental Health & Recovery Services in order to continue the operation of mental health programs and alcohol and drug addiction programs. Vote "Yes" for Issue 40.

Issue 41 is the renewal of a tax for the Toledo Lucas County Port Authority for all purposes, including economic and jobs development programs. Vote "Yes" on Issue 41.

My View

In the September 30, 2008 issue of the Toledo Journal, a special edition section spoke out against drugs in Ohio. The primary drug threat in Ohio is powder and crack cocaine.

The Journal tied drug use to violent crime in the state of Ohio. I wish the two candidates for president of the United States would get this specific and offer suggestions for turning the drug scene around.

We hear lots of talk about Iraq and the economy but it is the War on Drugs and the impact on our daily lives which continues to foster the slide of middle-class living in the central city. There has essentially been no change to treating heroin and other addictions since the 1970's.

Long-term inpatient treatment is rarely offered as an alternative to community treatment.

No one talks about interdiction or supply side intervention anymore. It is as though the drug problem quietly ended in Toledo. Of course, it has not.

Back in the 1910's Andrew Carnegie articulated the view that men of wealth ought to invest in society. Carnegie thought that rich guys had special insight with the root causes of poverty and should fix the issues.

Carnegie proceeded to give a lot of his wealth away, particularly for education and library funding around the country. Ithought of Carnegie the other day when I read that HCR Manor Care would receive \$30 million in state and city incentives to stay in downtown Toledo. Manor Care makes millions upon millions through Medicaid reimbursement every year. If Manor Care were struggling, I could see an incentive package to help them remain viable. But this appears to be \$30 million just to stay downtown. Why not stay just to be

good for Toledo? And did not the City Council give Manor Care a sweet nonprofit deal back in the 1980's so they could purchase the building?

The city deficit bodes ill for 2009. There will be more cuts in the budget based on the \$30 million Mayor Carty Finkbeiner claims needs to be cut this year. And, by the way, did the city's water reserve fund go from \$28 million down to around \$3 million? Doesn't an accounting firm report require a certain amount of cash in the budget?

Kudos to Bernadette Restivo. She is working as an assistant county prosecutor in Florida. She is the 11th member of the Restive clan who has found a niche in the law.

I still think Obama needs a get out the vote effort in Lucas County. An effective GOTV effort can result in one to three percent more votes.

Remember to vote for the Supreme Court justices. We generally have a 30 percent fall off in votes for judges.

Councilman McNamara Takes on Convenience **Stores**

Early last week, Evan Morrison walked into the A & P Gas Station on the southwest corner of Central and Stickney - across the street from Woodward High School and asked for a Black and

According to his notes that Morrison read later in the week during a press conference organized by Toledo City Councilman Joe McNamara to protest the proliferation of convenience stores, especially those that sell drug paraphernalia close to schools - as the clerk rose to get his cigar, Morrison also asked for "a scrubber and a glass rose."

The clerk placed all three items in a small black bag and charged Morrison \$5.90. Ironically, Morrison did not really receive the "glass rose" he requested. A "glass rose" is street parlance for a glass tube about four inches in length and about the thickness of a pencil. Typically the tube, with corks closing each end, is stuffed with a fake cloth rose.

In this instance. Morrison actually received a tube stuffed with incense rather than a rose. The clerk did not bother to tell him of the change before he placed it into the small brown bag. There would normally have been no need to do so because anyone requesting a "scrubber" (kitchen scouring pad) and a "glass rose" has only one thing in mind ... smoking crack.

The tube is the pipe and the pad is the filter.

Morrison, a University of Toledo student who managed McNamara's campaign for city council in 2006, had been asked by the council-



man to make the purchase, not for illicit purposes, but strengthen the

councilman's argument that gas stations should not be excluded from the Municipal Code spacing requirement that prohibits convenience stores from being located within 2.000 feet of each other or within 1.000 feet of a school, park, library or daycare center. McNamara calls the gas station exemption the [Toledo Council President Markl Sobczak amendment.

"This is a very serious problem in our neighborhood," said McNamara at his press conference on Thursday on the corner opposite the store. "It is a problem of saturation of convenience stores. I have proposed legislation to re-institute the spacing requirement that used to be a part of the Toledo Municipal Code. We have seen a proliferation of convenience stores in the

Tammy Howard is the owner of the corner gas station. She and her husband. Herbie Hancock, joined the press conference to take issue with McNamara's proposed legislation.

Joe McNamara is speaking out of both sides on his mouth," said Herbie Howard. "Growth is what the city needs most not shrinkage. As to the question asked about whether or not he was aware that the store had been selling drug paraphernalia. Howard said: "It's a free market economy. It is legal to sell these items.

An incensed McNamara shouted: "You better stop selling crack pipes at your store ... next to kids. You make me sick."

The issue before council on the convenience store legislation is whether the law is too restrictive on businesses - particularly big gas station chains - that would want to locate within city

City Sluggish on Removing Unsightly, Asbestos-Laden Debris in Central City



"This is as bad as it gets." said Toledo City Councilman Michael Ashford last week as he stood before a pile of rubble from the demolition of the 20unit apartment building on the corner of Hawley and Vance Streets.

"The City of Toledo has created a unique problem, the asbestos should have been addressed," said Ashford.

The building had been de-

molished on October 6 after it had been virtually destroyed by a fire the previous day. Following Environmental Protection Agency requirements, the City of Toledo has delayed removing the remains until testing for asbestos is completed.

This is way beyond reasonable," said Ashford. Neighbors agreed

"I have to breathe this is in every day," said Jacqueline Lothery, who lives next door

to the site. "Neighbors have experienced dust from the building going into their windows." According to Lothery, at least one such resident has moved from the neighborhood until the site is

The owner of the site is Staged Steps Real Estate LLC. The building had been operating as a group home but had been vacant for about a year prior to the fire.

City spokesmen say that they anticipate the results of the tests will be available in late October or early November

Obama Visit Stuns Workers at Chrysler Perrysburg

Wayne Blanchard, president of the UAW Local 1435 (Chrysler Perrysburg), received a call last Monday evening at about 8:00 p.m. from a representative of the Senator Barack Obama campaign asking if an Obama surrogate could stop by the plant the next day. The surrogate, Blanchard was told, could possibly be Bill or Hillary Clinton, Joe Biden, Gov. Ted Strickland, Lt. Gov.

Lee Fisher or New Mexico Governor Bill Richardson.

Taking the initiative, Blanchard asked if Obama himself could stop by since he was in the Toledo area for three days preparing for the final presidential debate.

"They didn't think that it would happen," said Blanchard a day after the event.

It would.

At 2:15 p.m. on Tuesday,

Blanchard was pulled out of a meeting by two members of the Obama campaign to ask if the candidate himself could come by the plant at the shift change (3:00 p.m.) for a meet and greet.

"With your approval, I'll call Chicago," Blanchard was told by one of the representatives.

Blanchard, of course, did not have to think too long before answering in the affir-







mative

"The Senator can be here in 25 minutes," the Obama staffer said after he got off of the telephone with Chicago headquarters.

"It all happened so fast," Blanchard said later still astonished at the surprise encounter with Obama. "He pulled up at 2:57 p.m."

"Wayne Blanchard, president," said Obama greeting the labor leader. "You are the man I want to be like."

"We shook hands and hugged," said Blanchard. "He asked about how things were at the plant and I told him of our struggles to hold on to jobs. He said he had heard that we had laid off 300 recently. I told him that we were going to lay off 100 more near the end of October."

"That's why I'm here ... to get elected," Obama told Blanchard. "The UAW is one of our best labor unions ... we need to make changes to our trade laws in order to keep jobs here."

Blanchard and Obama walked and greeted the union members during the shift change, a sight that enthralled the workers, said Blanchard because usually such high profile events occur at the Jeep plant or at Powertrain. "Everyone was ecstatic and glad to see him.

The member started chanting Obama's name as well as Blanchard's.

"Man, they love you out here," said Obama.

"They are only doing this because you are here," answered Blanchard.

Encounters with presidential nominees happen rarely, Blanchard noted when he told the story the sometime later

There's still time to vote early!

Early voting continues through November 3 and mailed in absentee ballots must be post marked by November 4 to be valid and counted in the General Election

We've got to get as many of our registered family members, friends, associates and acquaintances out to vote early as humanly possible. We've got to do it and we've got to do it now for a brighter future.

Ohio Democrats have registered close to 700,000 new Democratic voters.

With that number of newly registered voters along with committed democrats and adding those Republicans who have come to the side of our Democratic hopefuls, Ohio has an excellent chance of becoming a "blue state" and electing Barack Obama as the next President of the United States. 3. RELIEF TO HOMEOWNERS: 90day foreclosure moratorium for homeowners that are acting in good faith. Financial institutions that participate in the Treasury's financial rescue plan should be required to adhere to a homeowner's code of conduct, including a 90-day foreclosure moratorium for any homeownersling in their homes that are making good faith efforts pay

their mortgages.

4. RESPONDING TO THE FINANCIAL CRISIS: A Lending Facility to Address the Credit Crisis for States and Localities. Obama is calling on the Federal Reserve and the Treasury to work to establish a facility to lend to state and municipal governments, similar to the steps the Fed recently took to provide liquidity to the commercial paper market.

Obama's plan also calls for temporarily eliminating taxes on unemployment insurance benefits; keeping all options on the table to help our automakers weather the financial crisis; having the Fed and Treasury prepare for guaranteeing a broader range of liabilities of the banking system; and instructing Treasury to help unfreeze markets for individual mortgages, student loans, car loans, loans formulti-family dwellings and credit card loans.

Jamilah Jones: Young Professional Committed to Making Toledo the Best It Can Be

"I'm a little concerned about people's spirit in the giving of their time," says Jamilah Jones, doctoral candidate at The University of Toledo and president of the $Greater\,Toledo\,Urban\,League$ Young Professionals.

"No one is talking to our kids," says Jones, "or helping them develop soft skills such as conflict resolution and peer pressure issues. Too many are getting into the juvenile justice system too early. We bring together community leaders and high school students and talk about issues relating to violence?

Those sessions, dubbed "Let's Talk," are designed to additionally address issues of job training and what Jones calls "reverse career planning" or "what you need to do now in order to have a job in the future.

And, of course, bridging the gap in health care is a frequent theme of YP efforts in community service as is the case in this weekend's conference at the Park Inn.

Jones is also the coordinator of graduate student recruitment for UT.

Her long range goal is to remain in college administration, but preferably for twoyear colleges. "There are fewer levels of bureaucracy,' says Jones. "I believe in youth, education and access. UT says it is accessible but two-year colleges are accessible and affordable.

"We have a workforce that is in need of retooling and a two-year school serves that purpose a little easier than a four year college."

Obviously with such a $career\,path\,in\,sight, there\,can$ be no guarantees that Jones will remain in Toledo but she would have no problem in doing so.

"I believe that Toledo is a great place to live. It has a good community and a great feeling. I am committed to help make it the best place to be. I'm committed to working with kids here and I'm committed to working with the young professionals of the Urban League."

of 1502 N. Detroit in January 1958 and burned the mortgage on that property in just five years.

In 1969 Rev. John McKissick became the pastor of St. Paul and the church made numerous strides under his guidance. A Watch Care Program was established; a Department of Evangelism was formed; a credit union was started. Physical facilities were improved with the additions of air conditioning, paneling, carpeting, glassentry doors, a church bus, a parking lot and a lounge. Pastor McKissick retired in 1985 and was succeeded by Rev. Irece T. Bradley who served until 1990.

Rev. Floyd D. Smith answered the call to serve as pastor in 1991 and served until 1998. Rev. James Glover served in an interim capacity until November 2003 when current pastor, Rev. James H. Willis was named to lead the congregation.

Under the guidance of Pastor Willis, St. Paul has added a Young Adult Ministry, a Praise Team and has completed a number of repairs and restoration projects. The congregation is growing steadily and many young members have been added.

This Sunday, St. Paul celebrated its $90^{\rm th}$ anniversary – "Building Through the Years" – with the help of Rev. Kevin Bedford, pastor of the Historic Third Baptist Church, who delivered the proclamation, the invitation to discipleship and the benediction.

Warren African Methodist Episcopal Church – 160th Anniversary

The Warren African Methodist Episcopal Church was heralded as the first African-American Church in northwest Ohio in the Ohio Annual Conference Minutes of the AME Church in 1847. There were eight members and it was part of the Sandusky Circuit with Rev.

G.H. Gillespie serving as pas-

In 1852, when there were perhaps 300 African-Americans in Toledo, the annual conference decided that Toledo's 22 members were enough to constitute its own

Toledo from Kentucky via the underground railroad. He succeeded in raising funds with the help of Congressman James M. Ashley, to rent a frame building at the corn of Summit and Adams Streets—this would be the first black

Church of Christ congregation.

Rev. Lyman Liggins was

Rev. Lyman Liggins was assigned to Warren in 1968 and would become the longest-serving pastor. Under his leadership the church established the Warren Senior Citizens Program, a Mental Health Clinic, the Methadone Clinic and the Christian Volunteer Tutorial Program.

The church also completed two parking lots and renovated the lower level of the building.

Rev. Otis James Gordon, Jr. was assigned as pastor of Warren AME in 2003 after 11 years of service at Grace AME of Warren, OH.

Warren AME, in addition to being the oldest black institution in Toledo, is the oldest black church in northwest Ohio, the second oldest in Ohio and the third oldest black church west of the Alleghenies.

Warren AME Church celebrated its 160th anniversary this past weekend with a grand reception – "Celebrating the Journey – Embracing the Future" – on Saturday and service on Sunday with the help of guest Rev. Marvin McMickle of Cleveland, OH.



mission. Rev. J.C. McLaren was appointed pastor. The next year, Toledo was placed back on the circuit where it remained for nine years.

In 1862, a black minister, Rev. Henry Young, arrived in institution in Toledo.

Rev. Charles W. Warren of Pennsylvania was named pastor of the Toledo church in 1865. He passed away in 1874 but not before overseeing the building of a church at 17 North Erie Street. That church mortgage was finally paid in 1915 and subsequent improvements continued to be made on the property.

For 81 years, the congregation worshipped at 17 North Erie before the need for a larger building facility prompted Rev. Otis Haithcox to purchase a church at 749 Norwood Avenue from the

Commemorating 1808: Fighting for the Right to Dream October 24-25, 2008, University of Toledo College of Law, Toledo, Ohio

The UT College Of Law Commemorates the 200th Anniversary of the Prohibition of the Importation of Slaves into U.S.

In 1808, the importing of slaves into the United States was prohibited by federal law. To commemorate the 200th anniversary of this watershed development, a distinguished group of scholars will gather at The University of Toledo College of Law on October 24-25, to bear witness and discuss the significance of this important historical event.

The conference, "Commemorating 1808: Fighting

for the Right to Dream," is free and open to the public. It will take place in the Law School from 6:30 to 8:00 on Friday, October 24 and from 9 a.m. to 6 p.m. on Saturday, October 25.

The conference is cosponsored by the Graduate Program in Policy History of Bowling Green State University.

The significance of 1808 might be found in the life of a slave in the United States. Barbary was born

in 1787 in Africa and sold into slavery in 1800 in North Carolina to the Harrison family (of Founders and Presidents fame). In 1808, Barbary was enslayed, black and 21 years old. Conference speakers, an international and interdisciplinary group of scholars, will explore the question of how to keep slave stories such as Barbary's alive.

The conference will include discussion of other

developments that testify to the significance of 1808. Those developments can be found in both large and small events throughout the 19th, 20th, and 21st centuries: in the founding of Liberia in 1847 and its subsequent history; in the bloody Civil War in the United States; in Reconstruction, and in Jim Crow: in 1908, the year of birth for the late Justice Thurgood Marshall, the first African-American to sit on the U.S. Supreme Court; in the civil rights movements in the 20th century, and in the 1968 assassination of the Reverend Martin Luther King,

The legacy of 1808 can also be found in quiet moments, such as one captured by a 1948 picture of Ada Sipuel, an Africana Norman, Oklahoma courtroom, dreaming of becoming a lawyer.

"Our goal is to honor the memory of people and events in this important year for all Americans and for the world," said Benjamin G. Davis, associate professor of law at The University of Toledo College of Law. "I was dismayed that no other law school in the United States had developed a program to mark this anniversary. In working with my colleagues on this project, I have found increasingly just how special the role of Toledo and its environs has been in so many aspects of the issues of slavery and its aftermath - for example, in the Underground Railroad up to Buxton, Canada and in the co-



So long ago, when you were young and filled with possibilities, you thought you'd someday make a difference and change the world.

You had ideas and energy, and you were going to put them both to use. Someday, people would remember the contributions you made.

And then, some time between the late morning of your life and now, making a living got in the way of making a difference and here you are, wondering if it even makes a difference if you show up for work or not.

In the new novel The Right Mistake by Walter Mosley, a man fixes something that's wrong in his community. In the meantime, he fixes what's wrong with the way he's been living.

Once upon a time, Socrates Fortlow killed a man, then raped and killed the man's girlfriend. For that, he spent half his life behind bars. Socrates remembers the day he was paroled and how the breeze felt on his arms as he looked out the warden's window and listened to the voice of a woman he couldn't

Once out, he sold aluminum cans to get by and lived in an alley until a compassionate patron gave him a tiny cottage, rent-free. That was enough for awhile. But then, Socrates began to think.

He heard Vanessa Tremont stole Freddy Bumpus' family home, and he knew the place would make something better than a love-nest for a cheating woman. Socrates took the silver-shingled building, cleaned it and set up a table. He invited a dozen of the smartest people he knew from all over L.A., and he started Thursday night meet-

The Thinker's Meetings, they called it. A strong young killer from the 'hood, a grieving elder, a lawyer, a Hispanic carpenter, a Jewish entrepreneur, an Asian teacher, all sitting around the Big Table, speaking their minds one at a time.

And as word got around that the Big Nickel was a safe place, gangs began meeting there to make peace. A neighborhood day-care was established. A soup kitchen sprung up. People began watching out for one another in a place meant to come together to make a differ-



Socrates Fortlow never dreamed it would all make a difference in his life, too.

I didn't like this book at first, mostly because it seemed to meander and I couldn't figure out where it was going. About 35 pages in, it didn't matter any more. I was hooked, and author Walter Mosley had me rapt.

Right The Mistake is about class and race, male and female, religion and background and busting them all apart. It's a thoughtful story of a street philosopher who knows violence isn't the way, but has to keep reminding himself of it. And - at the core - it's a story about love and truth.

Far from fluff, The Right Mistake is one of those books vou'll think about for three days after you've finished it because it's so provocative. Don't let that turn you off, though. Read this book. Missing it is the big mistake.



The honorees for 2008 were: Dr. Francis Duffy, Mary Gregory, Daisy Smith, Dr. Herbert Stockard, Donna Todd and Dr. John Williams.

Dr. Francis Duffy, BS, DDS, agraduate of Libbey High School earned an undergraduate degree from Michigan State University in agriculture and, after serving with the U.S. Navyin World War II, entered The Ohio State University where he earned a doctor of dental surgery degree.

Dr. Duffy's 45 years in dentistry in the Toledo area were highlighted by his service at the helm of a nationwide research team that studied the effects of fluoridation. His study, completed in 1966, showed that childrenusing water fluoridation had a 55 percent decrease in tooth decay compared to those who did not.

Mary Gregory, RN, B.Ed., M.Ed., was the first African-American to graduate from the St. Vincent School of Nursing. Her career at St. Vincent's has included stints in operating room nursing, the instructor of surgery students, director of Manpower Development and Training Act Program for Surgical Technicians, instructor at the School of Nursing, director of the Sickle Cell Program, education coordinator of the Outreach Program and manager of Health Promotion.

Along with Donna Toddand DaisySmith,Gregory is a founder of the Toledo Council of Black Nurses

Daisy Smith, RN, BSEd., graduated from the Medical College of Ohioas are gistered nurse. From 1969 to 1975, she worked both as an assistant clinical manager at Mercy and manager at Parkview hospitals.

In 1980, Smith managed the Batavia Developmental Center and between 1988 and 1990, smith co-authored 10 articles in various health journals on subjects such as physical fitness, prostate cancer, blood vessel diseases, weight among adolescents, and so forth.

In 1998, a portion of the Cordelia Martin Health Center was named the Daisy Smith Clinic which has since been changed to the Daisy Smith Pediatric Center.

Dr. Herbert Eugene Stockard, MD, is a native Toledoan and Scot High School graduate. Dr. Stockard earned a bachelor's of science degree from UT and his MD from the Medical College of Ohio. His professional training has included a fellowship in nephrology. He is currently chief of staff at St. Anne's Hospital.

Dr. Stockard co-authored eight publications between 1977 and 1994, has been recognized twicewiththeOhioKidneyFoundation Medical Award, and four times as an Active Teacher in FamilyPractice.

Donna Todd, RNC, MSN and MS Ed/PH, graduated form the Medical College of Ohio as a registered nurse, a 3.9 grade point average and the award of "Best All Around Nurse." During her stellar career, Todd has been recognized as the first cer-

birth educator and obstetrical supervisor in Toledo along with ongoing certification in inpatient obstetrics, smoking cessation instructor for the American Cancer Association, Breast Self-ExamTrainingInstructor,Lamaze Certified Childbirth Educator and HIV/AIDS instruction.

Todd is a member of numerous service and community organizations and the president of the Toledo Council of Black

Dr. John Williams, DDS, is a graduate of Libbey High School and a former professional football player who won two Super Bowl Rings. In 1974, still in the middle of his football career. Williams returned to dental school earning his degree from the University of Maryland at Baltimore.

Nathan Hobbs, who also graduated from Meharry Medical School in 1924 and established his practice in Fast Toledo and became the first African-American to be a regular staff member of a Toledohospital-Riverside in 1938.
