

This Strikes Us ...

Counterinsurgency or counterterrorism?

It's a difficult choice for President Barack Obama as he reviews American strategy in

On one hand, Gen. Stanley McChrystal, the Afghan mission's NATO commander, and other military officials are advising Obama to pursue a counterinsurgency campaign bringing in an abundance of troops who will work in the villages and within the population to undermine the influence of the Taliban and attempt to bring democracy to the country. That is the "hearts and minds" strategy that has yet to work anywhere at anytime.

Obama sent 21,000 additional troops to Afghanistan earlier this year; McChrystal is expected to ask for 40,000 more within weeks.

Would that Obama could channel former Secretary of Defense Robert McNamara and former President Lyndon Johnson and seek their counsel about how well the old hearts and minds strategy worked in Vietnam in this nation's battle against communism.

The problem is also Afghanistan in this particular instance. Let's face it, nothing works in this desolate country. Ask the British and the former Soviet Union how easy it is to get bogged down in Afghanistan. It was in fact the Soviet Union that met its own demise in large part because of its failure to subdue its neighbor to the south.

The Soviets discovered that they could bomb and bomb, then threaten to bomb the mountainous country back to the Stone Age only to realize during the years of its ill-fated attempt at occupation that most of Afghanistan has never truly emerged from the Stone

On the other hand, advisors such as Vice President Joe Biden are urging the president to pursue counterterrorism. Counterterrorism in Afghanistan would mean the use of limited number of troops with the mission of carrying the fight to Al Qaeda even as that means reaching into Pakistan, our purported ally in the fight against terrorism.

Such a strategy would mean abandoning the villages to the Taliban and here's where the problem lies. You see, as much as we disliked communism during the Cold War, we really viewed the issue as one of world politics and the battle between the developed, capitalist West and the communist Soviet Union superpower.

The domino theory dominated our leaders' view of world politics rather than did any concern about the actual impact communism might have on Vietnamese villagers. Hence the U.S. military tactic of destroying villages to save them - we really wanted to save our

But the Taliban leaders bear no resemblance to Ho Chi Minh. The Taliban are about as fanatically evil-all in the name of God-as any ruling class could possibly be. And should they regain control of the country as the United States abandons the villages to them, the populace is in danger of extinction.

Picture this one example, if you will. Women cannot be legally educated under the Taliban and cannot be given medical attention by male doctors. Should the Taliban be left once more in charge, the ranks of those women with healthcare skills will rapidly be depleted and the life expectancy for Afghan women will drop precipitously.

So should the U.S. abandon its counterinsurgency strategy and leave the population of Afghanistan in harm's way? Regrettably, and in spite of the harsh reality of the situation, yes. We have no other choice.

Counterinsurgency campaigns simply do not work if the civilian population is unwilling to assist and we have seen absolutely no indication that Afghans themselves are in any way willing to do the work necessary to move their nation into the 21st Century.

Tribal leaders/warlords rule, politicians are hopelessly corrupt, poppy fields yield the only exportable crop. The fact is that in this instance, as in so many others, the people of the nation have to make a commitment to moving forward and throwing off their shackles.

The fact is, we don't have enough American troops to sit in Afghan villages and nurture their democratic aspirations. The fact is, America cannot make it work simply because it ems the right thing to do.

As has been said so many times, we cannot police the entire world.

History has shown us that the military's request for an additional 40,000 is only the beginning of a quagmire that will ultimately require hundreds of thousands of troops before we realize, once again, that we cannot rebuild nations through American military might.

Years ago, as he contemplated sending the first fighting forces to Vietnam, Lyndon Johnson scoffed at the suggestion that the job might require as many as 300,000 troops. Four years later, we had over 500,000 troops in the country and the military was seeking

Obama has to make the tough decision not to get caught in the same trap.

Missing Essentials

Whether moving merchandise or promoting proposals, hawking goods and services or peddling ideas, marketers are acutely aware that tough economic times cause most of us to live up to the aphorism of Oscar Wilde: "A man who knows the price of everything and the value ofnothing." These sellers and promoters are also cognizant that there are those of us who have "no value except price."

Induced by the prospect of new jobs and increased revenues for a comatose economy, a Blade/Ohio Newspaper Poll reports that nearly 60 percent of Ohio voters support the proposed constitutional amendment permitting gambling casinos in Cleveland, Columbus, Cincinnati and Toledo known as Issue 3.

While the proponents of Ohio gambling casinos have heavily promoted rosy revenue projections and job forecasts, there has been much essential information left out of the conversation. A review of the National Gambling Impact Study Commission's report and empirical literature conducted by organizations without a vested interest in the outcome reveals that the costs of casinos are at least 1.9 times the benefits (Grinols, 2001).

The value of investments in jobs and future revenues as promised by Issue 3 cannot be determined solely by estimated (and often disputed) revenue projections, but must also be evaluated by the consequential financial and social costs which arise as well as a from a clear understanding of who will pay or bear these costs.

What are the costs?

The most direct costs revolve around the subject of crime. Eight to 10 percent of the total crime in an area where a casino is located can be attributed to the presence of casino gambling, according to researchers. Bordering towns, counties or areas around casinos also show increased crime rates. Casinos, therefore, require an increased police presence and protection both in and around the areas of gambling activity. Who pays for the increased police, fire and safety budgets? Not the casinos!

Also to be considered is whether safety will be compromised in other areas such as the inner city by administrative decisions to shift police manpower to casino sites, leaving other portions of the city undermanned.

It has also been shown that typically one percent of gamblers account for 50 percent of wagers and that heavy, problem and pathological gamblers provide 25-50 percent of all casino gambling revenues. However, what is significant is that 62 percent of these problem gamblers who seek treatment admitto committing illegal and

criminal offenses such as stealing in order to finance their gambling.

This crime or safety cost often spills over into business and employment expense through lost productivity, lost time and unemployment, sick days, extended lunch hours, leaving early and returning late to work from gambling. Many gamblers also report losing a job due to gambling addiction.

Legal and collection costs resulting from the bankruptices encountered by a sizeable number of gamblers often find their way into the legal system for court time and resources as compulsive gamblers often stiff creditors (as well as family members) to finance their gambling after exhausting their personal resources.

Another cost seldom factored in the evaluation of gambling includes the disproportionately higher suicide rates among gamblers than the general public. Deaths in Las Vegas, Atlantic City and Reno were up to 2.5 times more likely to be a result of suicide than deaths in other comparably sized metro areas. Depression and other stress-related illnesses are also associated with gambling and flow into medical and social service costs including welfare, foods stamps, unemployment and related therapy/treatment costs.

All of these social costs and externalities are paid primarily through the government from taxpayers and place a burden on the remainder of society that would not be present in the absence of gambling.

Finally, any policy should be evaluated in light of not only the benefit of business profits but also the social needs, concerns and inequities that confront children and families. Gambling, particularly in tough economic times, puts enormous stress and strain on family relationships often resulting in divorce, separation, spousal abuse and child neglect as well as often opening the door to juvenile crime, teenage

pregnancies and a host of other dysfunction to communities that desperately need strong families and healthy relationships to stem the tide of poverty, hopelessness and despair.

Contemporary studies show that all of the above gambling costs can be quantified by the amount of money it takes to remove the undesired resultant problems and side effects. The resources required by the non-casino population to address the consequences of gambling as well as the value of assets lost to other uses in society, are rarely considered.

However, when the costs and information that has been withheld by Issue 3 proponents is revealed it indicates that the total price required for the acquisition of gambling jobs and revenues is more than it is worth.

On November 3, 2009 Vote No on Issue 3. It is a bad bargain.

Neighborhood Cleanup Brings Forth the Volunteers

The City of Toledo, Organized Neighbors Yielding Excellence (ONYX), Neighborhood Housing Services (NHS) and the Economic Opportunity Planning Association (EOPA) brought together approximately 150 volunteers last Saturday, September 26 to help keep another significant portion of Toledo "clean and green.'

Last weekend's cleanup took place on Woodland between Hoag and Hawley as the volunteers assisted their neighbors with a general clean-up.

The legion of volunteers trimmed sidewalk grass, bagged trash, scraped fronts of houses, swept, raked, brushed a two-block area during the three-hour clean-up.

According to Jimmy Gaines, executive director of ONYX, the cleanups are scheduled on a twice-quarterly basis but this one was slightly different.

"We are taking all our programs from the different agencies, along with money from the Obama stimulus package and combining them and attacking the situation holistically," said Gaines. So

while one agency might have the funds to weatherize a house and another might have the funds to repair a roof, these groups are doing a bit of everything to all the houses in one neighborhood.

"The reason we chose Woodland is that it is a tipping point residential area where people do a good job already of maintaining their properties so adding a little money goes a long way," said Gaines.

The clean-up is just the first phase of the changes that will occur along that strip of Woodland. Soon, the agencies will move in again to repair all of the exteriors that are in need - roofs, windows, doors, porches - along with painting the exteriors.



That there is only one full-length biography book of Tatum's life? It is titled Too Marvelous for Words by James Lester?

'That Tatum's mother played piano and that his father, Arthur Tatum, Sr., was a guitarist and an elder at Grace Presbyterian Church in Toledo, OH?

 $\cdot That \, Tatum \, was \, blind \, in \, one \, eye \, and \, partially \, blind \, in \, the \,$ other? (He suffered from cataracts of disputed cause which left him blind in one eye and limited vision in the right eye. Surgeries improved his condition only slightly and the benefits were reversed when he was assaulted in 1930 at age

One of Tatum's favorite pieces was Eubie Blake's "I'd Give a Dollar for a Dime," which O'Neal often sings in the

This year, your mom sent you to school with a big box of tissue, just like every other year. You keep it in your desk or locker, in case of sniffles.

Except this year, you've also got a bottle of hand-sanitizer, a bottle of liquid soap and you might be wearing a mask before springtime. You don't want to get sick, so maybe you're getting a flushot, and you take a vitamin every morning with breakfast.

But you're wondering. What's going on inside your body, anyhow? How do germs you get on your hands make you sick in your stomach? Read the new book *Open Me Up* by various authors and you might be surprised.

We humans are pretty coolcreatures. We feel a wide range of emotions and can think complex thoughts, make art, understand science and create ways to communicate. We are able to adapt to any climate. We may look basically alike – with two eyes, one nose, two ears, and

so on – but we're very, very different in many ways. Your face and your eyes, for instance, are so unique to you that either can be used as "passwords."

But as fascinating as your outside is, your innards are doubly so...

Take your appendix, for instance. It's off to one side and doctors used to think it was a useless organ. They know now that, even though you can live quite nicely without one, your appendix actually works to keep you healthy!

Other parts of your body make sure you can stand, sit and walk. Youwould collapse if it wasn't for your skeleton. If it wasn't for the muscles that make up your butt, you wouldn't be able to run or jump. Your brain can hold phone numbers, read maps, count coins and understand language, of both the oral and body types. What your tongue tastes can trigger memories in your mind, and


your eyes work with your ears and your feet to keep you from falling.

If you're thirsty, hungry, or tired, your body will tell you. And if anything goes wrong, your body will tell you that, too, with fever, sneezes, and more.

Make no bones about it, your body is pretty impressive!

With all the reports of HINI, MRSA, and the alphabet soup of illness this fall, it's easy to see why kids might get worried about what could happen. Open Me Up demystifies the human body and makes health issues easier to understand.

Starting with an overview and a look at medicine from centuries ago, this book lightly covers human anatomy and physiology, bodily quirks, cool science, the workings of doctors and other medical professionals, and new things on the horizon. Kids will also find tidbits and cartoon drawings that



make this book seem less like learning and more like fun. Excellent for middle-

school readers, this is a good

book to have around to answer questions that will inevitably come up in this season of Big Flu. *Open Me Up*

is a book they'll open again and again.

telling victims it is their fault because they could have stopped it.

Let me share with you some truths:

·Sexual abuse is any behavior with a child where the intent is to control or sexually arouse them.

·Sexual abuse is a betrayal of trust involving overt or covert sexual actions - direct or indirect, verbal or physical - be-

tween a child and a trusted adult or authority figure.

·Sexual abuse between a child and adult or authority figure is against the law and morally wrong.

·Sexual abuse involves some type of power and control. Parents, still have power and control over their 19-year-old children!

·Sexual abuse perpetrated by a family member or known adult is usually progressive in nature. Meaning it can start as "innocent" hugging or kissing and slowly lead to penetration.

·Consent includes more than saying "yes." It includes the ability and/or power to say "no" and enforce it.

·Consensual sex must involve equal power.

Considering the above truths, Mackenzie, although she states it, did not have "consensual" sex with her father. I can't imagine who is counseling Mackenzie and would allow her to blame herself for her father, a parent and authority figure, taking advantage of his parental role with her. As a survivor of incest and child sexual and in my work with survivors over the last 20+ years, I have heard many women like her say they were responsible, they could have stopped it. My immediate response is "you were absolutely not responsible!" I let them know that maybe, just maybe they could have uttered the word "no" but because of the authority and power differences they did not have the power and ability to enforce that "no."

Incest and Child Sexual abuse of children in our society is a public health problem. In my opinion it

is at an epidemic level. Statistics tell us that 1 in 4 children will be sexually abused by the time they are 18 years of age. 1 in 4! UT College of Pharmacy Breaks Ground


