## The Prosperity and Poverty of Black Pain

*The genius of our black foremothers and forefathers was ... to equip black folk with cultural armor to beat back the demons of hopelessness, meaninglessness, and lovelessness. - Cornel West*

The National Urban League's publication The State of Black America 2011 is now available. Never mind picking up a copy though, just pull out whatever previous edition you have available. Nothing has changed much in the past 20 or so annual reports except perhaps the year of publication.

The educational disparities are still there. The black genocide and other social dysfunctions persist. The gap between black and white health, wealth and employment remain or have widened.

Why do the poor and minorities receive negligible benefit in the form of positive outcomes despite the appropriation of billions of dollars for social services?

Some, privately reason that a "pro-status quo" social services system itself, has an innate need to perpetuate its own existence and is unable to do so if its clients were actually brought to a state of wellness, delivered unto self-sufficiency or truly liberated from the clutches of their problematic circumstances.

The system, whose foundation rests upon teaching people that their value lies in their deficiencies or inadequacies, has thus become a gold mine by giving poor people services rather than income, but providing wealth and stability to those who run or work in it. Yet the poor themselves are not bettered and their problems are never solved.

Others, insist that "you can't build the community by taking away community responsibilities and giving it to professionals who have no interest in bettering the community."

Indeed, African-American churches, the "oldest, strongest and most valued institution in the African American experience" who, along with other black community groups, have traditionally "been our social service center, political academy and financial institution" find themselves currently isolated from larger public agencies and disconnected from the tax-payer provided dollars used to fund black pain.

In fact, the leader of one African-American agency asserts, "The political and bureaucratic social service establishment is inept at community outreach but their policies actively discourage the participation of minority social service agencies."

The lack of access to resources for social service delivery and black self-help continues to be the community's "major unresolved dilemma."

Yet churches and black providers - possessing the unique knowledge or the cultural competency to effectively handle black pain - are counted on to help fill the gap between un-addressed need and available human services. Only they are expected to do it for free and serve without access to the funding mediated by the larger organizations.

Research confirms that black and other providers of color have the capacity to touch all aspects of family life and do provide many benefits.

Celeste Watkins-Hayes, PhD, writes: "They are a face that represents a life that was advanced through education, job experience and can serve as an example. Black providers are also often able to tap into shared experiences and intra-group dynamics including subtle but meaningful assertions of power" that others might not be able to.

However, black community providers, despite their long tradition of caring for their own through slavery, segregation and the civil rights era, face many criticisms.

Many from the dominant culture refuse to legitimize the black institutions claiming that they are substandard, poorly managed, inept at handling funds or accusing black folk of not yet having developed competency in the art of working together.

As a result, black pain sadly continues unrelieved while the administration and allocation of funding rests firmly with whites.

How can the work of black church and community providers co-exist with that of the larger social service system and this dilemma be resolved?

It will take a marriage of the larger social services system with those who are most able to assist families because they understand the social and cultural dynamics and reside or operate where the families they attempt to help also reside.

Only when the larger system collaborates with smaller agencies of color - not merely through funding, but also by providing assistance in how to maximize scarce resources, educational and technical support functions and help in interpreting legislation - can both systems coexist in a way that will effectively serve the poor and communities of color while achieving the positive outcomes which build community and provide real change.

# Jay Black Is Poised to Revive the Black Community's Chamber of Commerce

Newly reconstituted, the Toledo African American Chamber of Commerce (TAACC) is back ... again. This time with a new approach, a new officer lineup and a new attitude about what works and what doesn't when it comes to promoting black-owned businesses.

"We're like a start-up business," says Jay Black, president of the organization. "A grass roots organization."

Along with Black, a former banker and former City of Toledo chief of staff during then-Mayor Jack Ford's term in office, the new Chamber's officers are Vice President Vince Wiggins, Secretary Laneta Goings and Treasurer Art Jones.

When Black was approached to take over the reins of the Chamber, formerly the African American Bureau of Commerce and, before that, the Northwest Ohio Black Chamber of Commerce, he asked himself "who's advocating for black businesses in town on a

consistent and systemic basis?" He looked around and was forced to answer: "No one."

So he set out to work on changing that without, in the process, trying to reinvent the wheel.

Black held a series of conversations with the NAACP and the Greater Toledo Urban League's leaders and out of those talks came an agreement to collaborate.

"We've agreed to work together in those areas where we can," he says. To that end, the Chamber plans to focus on economic development, the GTUL on workforce development and the NAACP on social injustices within the economic realm.

In keeping with its mission statement, Black mentions three tasks that the Chamber can take on immediately. First, he plans to keep the black business community informed about the opportunities that are available. There are, of course, large projects such as the Hollywood Casino

that will require the Chamber's attention but there are always plenty of smaller projects as well, Black notes.

The Chamber will serve as an information clearing house for black-owned businesses.

Secondly, Black says, the Chamber has a role as an advocate for black businesses. That will entail meeting with larger, majority-owned companies and organizations to urge them to follow the lead of those who already set goals for minority participation. He cites the example of Penn National, operator of the Hollywood Casino, and The University of Toledo as entities that have taken steps to set such goals. UT, says Black, has set goals of 15 percent for all construction contracts and 18 percent for goods and services contracts.

"That's pretty aggressive for an organization of that size," he says approvingly.

The Chamber's third im-

mediate task will be to help those in the African-American community "to focus on those things they can do to help themselves."

This third matter is an educational process, says Black, that includes promoting goals such as keeping dollars in the black community and working cooperatively when possible to build capacity.

"How do we work together and ensure we have a healthy economic community?" he asks rhetorically. He has some suggestions that would fall along more long-term goals.

He views the Chamber as an instrument that can be used to promote an entrepreneurial spirit among young people. It's a spirit that has been missing for generations in the black community, says Black.

And more concretely, at some point in the future, Black would dearly love to develop opportunities for local business owners by organizing trade missions to West Africa, which is about

to explode economically.

But, above all, it is vitally important, says Black, to engage black churches in any discussion about the economic well-being of the African-American community.

Black churches can be a vehicle to help the community become economically viable," he says pointing out the importance churches have historically had in the community.

The TAACC will be holding a membership drive this Wednesday, September 28 at Our Brothers' Place on Huron Street from 5 to 7 p.m.

## University to Celebrate Right to Read

"Free Your Mind: Read a Banned Book" is the theme of the 14th annual Banned Books Week Vigil, which will take place Thursday, Sept. 29.

UT President Lloyd Jacobs will join faculty members and students, as well as a local author and newspaper reporter, to give short presentations from 9 a.m. to 5 p.m. on the second floor of Sullivan Hall.

"The right to read freely empowers us to learn about subjects some consider taboo or politically unacceptable," said Paulette D. Kilmer, Ph.D., UT professor of communication and one of the organizers of the event. "The U.S. Constitution protects free speech because the unfettered flow of ideas keeps our democracy vibrant and encourages embracing cultural differences that enrich us as a nation.

"Most of us take for granted our reading privileges because we were fortunate enough to be born in a country where freedom of expression prevails," Kilmer said.

In the fourth week of September, the American Library Association, the American Society of Journalists and Authors, the American Booksellers Association and hundreds of other sponsors of Banned Books Week have inspired citizens across the country to hold events celebrating intellectual freedom.

During UT's event, banned books, coupons and other items will be given as door prizes throughout the day. In addition, coffee, doughnut holes and bagels will be served in the morning, followed by a vegetable tray around lunchtime and mini-sandwiches later in the afternoon.

Serving with Kilmer and Sheldon on the Banned Books Week Vigil Planning Committee are Linda Smith, Ph.D., UT associate dean of the Honors College; Arjun Sabharwal, UT assistant professor of general libraries; Cynthia Ingham, Ph.D., UT assistant professor of history; and Elaine Reeves, UT associate lecturer of general libraries.

Benefactors of the free, public event are the Society of Professional Journalists, the UT Department of Communication, Carlson Library and the UT Honors College.

## Toledo Urban Federal Credit Union Gets Ratings Boost

The Toledo Urban Federal Credit Union (TUFCU) received an improved credit rating during the second quarter of 2011 from a bank research firm.

BauerFinancial Inc, of Coral Gables, Florida gave TUFCU a one-star grade which reflects the success of the local credit union's \$250,000 capital campaign that began in March of this year.

According to Suzette Cowell, president and CEO of TUFCU, the credit union is planning to raise another \$1 million through a second campaign that will start this weekend. The kick-off for that campaign is this Friday's Annual Meeting and Appreciation Banquet that will take place at The Toledo Zoo's Nairobi Pavilion.

Funds from the new campaign will be used to enhance the credit union's ability to lend and to help build a new facility at the corner of Dorr and Detroit.

The improved credit rat-



ing by Bauer was predicted by Cowell back in March when she noted at that time that a number of individuals in the community had stepped forward to help with the campaign. Among that number was John Szuch, chairman of fifth Third Bank (Northwestern Ohio), who persuaded his bank and five

other institutions to place seven-year notes worth \$50,000 with TUFCU. Szuch is one of this Friday's honorees for his efforts in assisting the credit union.

# Joyce Lewis: Author Realizes Dreams with Publication of First Book

As a child, Joyce Lewis hated to read and could not understand how a book such as *Green Eggs and Ham* by Dr. Seuss could help her realize her dreams, she explains all these years later. How ironic it is that Lewis, who hated to read so much as a child, will achieve one huge dream next month when her first book is released by Zoe Life Publishing of Canton, MI.

And how appropriate it is that her first book is a child's book and a tale of youngsters learning to make their own dreams come true.

Lewis's book, *Sir Haunz & Gertrude's Great Escape*, is a story of two children whose father has lost his job

due to the downsizing of his automotive plant. Their parents make a difficult decision to send their children to live with relatives while they try to get back on their feet.

Tragedy strikes and the children are left homeless in Chicago and have to learn to fend for themselves. Haunz discovers that he has a gift and he uses it to overcome obstacles as the children finally escape hopelessness and poverty.

"I flunked fifth grade and a teacher told me that as long as I stayed pretty I would be all right," says Lewis, a special education teacher with Toledo Public Schools. "I decided then that what some-

one else said about me would not define me or limit my future. I went to college, got a degree and now I help those children, who are the most challenged in life because of educable or mental impairments, have an opportunity at living the best possible life they can lead."

Eventually, Lewis, who had once despised reading, took up the pen and wrote a poem. One poem led to another and several years ago, dozens of poems later, she had an idea about a children's book based upon an updated version of the Grimm's Hansel and Gretel story. During the writing process, that idea did not survive for very long.

"The story took its own turn at the end of chapter one," says Lewis. "It became more of its own story rather than a modern day witch tale. It became more of a gospel inspiration story."

How long did it take the fledgling author to complete the task?

"Forever!" she exclaims with just a touch of feigned exasperation.

Nine months to write her first book; six months to tweak it. Then, as is often the case with such first efforts, the book "lay dormant for a long time," says Lewis.

Then again, not quite so dormant.

Lewis started reading chapters of the book to her students whose positive re-



sponse encouraged her to seek ways to get the book published. At one point Lewis gave the book to a third-grade student she was tutoring. The young girl, who read at a fifth grade level, took about an hour and a half to digest the book, alternately laughing and crying at the story.

When she was done, she asked Lewis: "How did you know how I felt?"

Well, of course, now she absolutely had to get it published. As luck would have it, and fortunately for young readers everywhere, finding a publisher was not as daunting a process for Lewis as it typically is for first-time authors.

She spotted the name, Zoe

# Museum Acquires Two African Objects Via Apollo Society Selection

The Toledo Museum of Art has acquired two objects through the annual selection process of its art acquisition group, The Apollo Society. This year's curatorial theme was African art, and the final selections represent the work of a contemporary Moroccan-born photographer and an unknown 19th-century sculptor from what is now Tanzania.

The compelling photograph *La Grande Odalisque*, by Lalla Essaydi, references Jean-Auguste-Dominique Ingres' famous 1814 reclining nude, *La Grande Odalisque*. That oil painting, residing in the Louvre in Paris, belongs to a genre that came to be known as Orientalism. The term describes the exotic and sensual way in which 19th- and early 20th-century Western artists (mostly male) depicted the Muslim culture of North Africa and the Middle East.

In her photo series *Les*

*Femmes du Maroc*, which includes *Le Grande Odalisque*, Essaydi reacts to and in some cases recreates these Orientalist images, making subtle changes in poses and facial expressions. Her subjects are draped in white (mourning) cloth and covered in dense Arabic calligraphy done in henna. The words are largely illegible but come from the artist's own musings about personal identity and freedom.

Born and raised in Morocco, Essaydi married a Saudi prince and lived in Saudi Arabia for many years. She entered art school at age 34 in Paris, finally receiving her MFA in photography and painting from the School of the Museum of Fine Arts/Tufts University in May 2003.

"Lalla Essaydi is among a key group of contemporary Muslim women artists who are making provocative statements about women's role in modern



society," said TMA Director Brian Kennedy.

Figure of a Woman Carrying a Child is a wooden sculpture from the Tabwa peoples in central Africa dating to pre-1880. The subject's short, bent legs, rounded hips covered by a

fiber skirt, elongated neck and torso, pierced ears and cap-like braided hairstyle are indicative of the culture's idealized female beauty. The patterned scars carved into the figure's torso, back, neck and head represent rituals of tribal initiation,

whose rites deliberately left scars to dramatize the struggle of people against the forces of nature.

Tabwa villages were autonomous until colonization by Christian missionaries began in the 1870s. Because these ancestral figures were

perceived to be idols, most were destroyed by Western occupiers. This example, believed to be one of the only Tabwa maternity figures from the 19th century to exist, was carried out of Africa about 1880 by a man who was likely the brother of one of those missionaries.

The Apollo Society—named after TMA's Henri Matisse mural *Apollo*—was formed in 1986 by Georgia Welles and her late husband David to select and purchase significant works of art for the collection. Each fall, Apollo Society members choose a general category, such as the art of Africa. The TMA curatorial staff then researches objects that would be important additions to the collection. At the selection dinner in the spring, the offerings are revealed and members cast their votes for which work(s) will be purchased.

You rarely see country music fans in heated arguments about who is the best.

But our music was born in struggle. It was born out of a need for a voice.

As long as there is rap, there will be discussion about who is the best rapper.

Period.

(Continued from previous discussion) Once, Lil Wayne flipped a Jay Z track, it was a definite run at the throne. He even opens the song by upgrading his previous claim.

No more "best rapper alive since best rapper retired."

He boldly says "This is a public service announcement, Lil Wayne Weezy F Baby IS the best rapper alive." Then addresses NYC, addresses New Orleans, tells America "goodnight" and goes in like I had never heard him go in before.

Even referencing Jay Z's original version of the beat he just flipped...

On "Show Me What You Got", Jay spit "I am the Mike Jordan of recording, you might wanna fall back from recording" at no one in particular.

On Wayne's version it became "when it comes down to this recording, I must be LeBron James if he's Jordan. No, I want rings with my performance, I'm more Kobe Bryant of an artist" and his rhymes from there on easily rival Hova's verses on the same instrumental. It was the moment I was no longer annoyed by the sound of his voice and lack of creative wordplay. I became a Wayne fan for life.

While Hova was making his return, Lil Wayne does one thing that the elder Mr. Carter never did. Even during Jay Z's heyday, which lasted from about 1998 to about 2006, his voice rarely landed on other people's songs. Wayne did the opposite, he whored his flow out to the entire industry. Through remixes and guest spots, Lil Wayne was

on the radio all day with no album out. Also happening right at the start of his takeover was a strategic move that now seems directly planned to challenge Jay Z.

Out of all the BEST IN THE GAME rappers who had worn the crown at some point throughout rap's history, Jay Z was the only mogul.

The only one rapping on records distributed by his own record company.

Even though there had never been serious talk of Lil Wayne becoming an executive, all of a sudden he is rewarded with a boutique imprint under Cash Money to be called Young Money. Honestly, I thought it was the dumbest thing ever.

Nevertheless, Wayne had all the ingredients to take on Jay Z for the undisputed heavyweight title.

Except chart success.

Wayne had never had a truly break out, platinum plus album that locked down the industry. He also never had true crossover hits.

In 2008, he did both.

Even accomplishing the feat of being THE ONLY black rap artist to have an album scan a million units the first week of its release (only other rapper who did that was Eminem).

ALL LOVE

Jay Z and Lil Wayne have been on each other's albums, and Wayne is even managed by the same exact duo who manages Kanye West. Gee Robinson and Kyambo aka Hip Hop run a management company known as Hip Hop Since 1978. Their biggest clients: Drake, Young Jeezy, Lil Wayne & Kanye West. Both men have also been down with Jay Z for nearly 10 years, his album liner notes are full of credits listed to them.

It was all good just two years ago.

Wayne had a legitimate shot at being the best in the game.

Jay Z was ruling in his own way as an artist and an executive.

Both hip-hop heavyweights joined together for "Hello Brooklyn," and all was well.

Then Jay Z had a stellar year, and someone had to hate.

You know who I blame for this current situation?

CASH MONEY CO CEO BRIAN "BABY" AKA "BIRDMAN" WILLIAMS.

In 2009, Jay Z killed the rap game. Blazing single after blazing single and on some true icon status, he surpassed Elvis Presley for most num-

ber one albums. He now sits number two behind The Beatles, for most number one albums of all time.

Just as before, with one star rising and the other falling, Jay's return to dominance over the genre happened just as Wayne was going through two not so favorable situations:

1. Being seen as second-best in his crew behind newcomer, Drake.

2. Preparing to do a bid at Rikers Island for a weapon and drug charge.

MTV's yearly poll of what rapper was currently the top dawg found Jay Z victorious.

Then Weezy's "daddy" had to chime in.

Unhappy with MTV congratulating Jay Z with the Hottest Rapper In The Game for 2009, Brian "Baby" Williams goes on record to various hip-hop media outlets saying the following:

"I don't think Jay Z is the best emcee in no kind of way. Wayne the best, he do the most and he get the most money. I don't think no n\*gga in the business get more money than us. So how could you be the best if you don't make the most money?"

He goes on to say in the same interview "who making the most money? That's #1 to me.

F\*\*k all that rap sh\*t."

Now this is the man who runs the company Lil Wayne and his smaller company are signed to. In weeks following this comment, Birdman went on record on B.E.T. and various internet and radio rap shows continuing to claim that not only was Wayne a better lyricist but that he and Wayne have more money than Jay Z.

At this point, any rap fan with half a brain was laughing out loud at how delusional Wayne's boss and surrogate father seemed to be.

Then the Forbes list for that year came out.

Now also, anyone even slightly familiar with this business can tell you that for the last 10 years Shawn Carter and Sean Combs have made the Forbes top earners list look like a private game of seesaw. One year this will be number one and the other number two, then the next year they switch. That's been going on for 10 years.

Nowhere in that has anyone from Cash Money even broken into the top five.

But like Hova says... "women lie, men lie... numbers don't."

Forbes magazine puts Jay Z's wealth upwards of \$400 million.

The very same authority on net worth puts Birdman's

net worth at around \$100 million.

On YouTube, Birdman a/k/a Baby Williams says Forbes is wrong and that he's actually closer to half a billion than the estimated \$100 million.

After going on record dissing Jay Z for a year, and making all these claims about who has what money Baby needed to be addressed and Hovito did so earlier this year.

On "H.A.M." he spit "really, half a billi? Really you got 'baby' money. Keep it real w/ni\*\*az, ni\*\*azaint got my lady money".

That was an obvious shot thrown, but not so much at Wayne but at Baby.

Using his own name against him nonetheless, in a stroke of typical Shawn Carter genius.

But that song came out damn near a year ago.

And Cash Money or Young Money never fired back.

When Lil Wayne admitted that not only had he heard "H.A.M." but that Kanye had played it for him and he didn't seem upset.

He went on record saying "I wouldn't make it a competition, because actually, the subject that he's talking about in that line... I can't even box with God. I'd be the first one to tell you that given my wit, and the type of person I am... I'd capitalize and play off it. Yeah, I definitely would."

So in the same fashion that Jay Z reeled Nas in and used a dis track to fuel a CD release, Wayne let Watch The Throne come and go right before his Carter 4 hit shelves he set the rap world on fire with his long awaited response: "Talking about baby money, I got yo baby money. Kidnap yo b\*tch and get that how much you love yo lady money."

So here we find ourselves.

Although Eminem could be considered the best in the game for many of the same reasons and even though Kanye, T.I, and Drake are all capable of one day occupying the lane themselves. Right now we find ourselves divided over who runs this ish.

Wayne's newest album is on pace to outsell Jay Z & Kanye's Watch The Throne by nearly DOUBLE.

Wayne's Young Money record label has something Jay's Rocafella NEVER had,

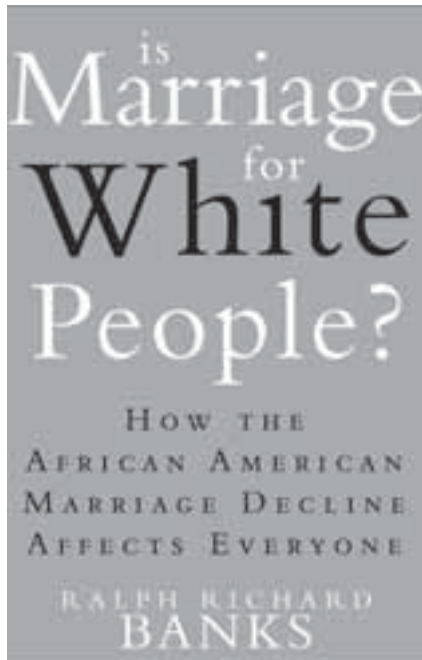
**“Is Marriage for White People?” by Ralph Richard Banks**

are married?

Probably fewer than those who wish they were. Ralph Richard Banks says that “African Americans have become the most unmarried people in our nation.” Nearly 70% of black women are unmarried and three in ten may never marry.

Marriage used to be the ideal, says Banks. It was the only socially acceptable way to be sexually active and to procreate but in the 1970s, things changed, due in part to the availabilities of birth control and no-fault divorce. Still, marriage is the “goal” for most Americans.

One of the main issues within the African American community, says Banks, is that there’s a shortage of college-educated, single black men. Incarceration is the “most talked-about aspect of the numbers problem” and it’s one that lasts: jail records tend to confer a long-time stigma of prison that women won’t generally accept. Not even a post-

prison college education erases that reluctance.

So what are the ramifications of the lack of available, desirable black men?

Black women rarely “marry down,” so a lot of single sisters are more willing to “man-share,” says Banks. More and more single black men are rotating several girlfriends because they’re “having fun” and because there’s no urgent reason to behave otherwise. Black women feel powerless to stop this because “black men are in short supply” and a part-time relationship is better than nothing.

So what can be done? Banks has one main

idea: black women don’t need to remain single. They can open their minds and “marry out.” Though it seems to be a conundrum, “If more black women married nonblack men, more black men and women might marry each other.”

Without a doubt, there will be some readers who’ll want to throw “Is Marriage for White People?” out onto the street. Like any author with a possibly-contentious subject, Ralph Richard Banks may anger some people – but there will be many who will applaud what he has to say.

Banks, a married educator, has statistics and

facts to back up his information – so much so that about a third of this book is referential. He takes things further with interviews and an explanation on how he came to his thought-provoking conclusions. This is an intriguing book, both for the information that Dr. Banks presents and for the results he ends up with.

But will it work? That remains to be seen but, in the meantime, “Is Marriage for White People?” is guaranteed to start a lot of conversations. If you’re single and don’t want to be, vow to read this book soon.

The groom can’t help himself.

His smile is ear-to-ear as he watches his bride slowly make her way down the aisle. He’s so in love with her, and for good reason: it’s their wedding day and she’s lovely, both inside and

out, a vision in white. But what color is her skin?

According to **Ralph Richard Banks**, the odds are that it’s not black. Learn more in his new book “**Is Marriage for White People?**”
