Misfortunes, Missteps and Opportunities

With the 2016 presidential electoral campaigns hitting peak stride, it could be a fatal political mistake to overlook Toledo's mayoral election, which will take place in 2017. Contenders are already lining up to challenge incumbent Paula Hicks-Hudson, Toledo's third African American mayor and the city's only black woman chief executive.

Unlike in her victory to complete the final two years of the late D. Michael Collins' unfulfilled term, should Mayor Hicks-Hudson survive a September 2017 primary, she would compete head to head rather than the seven person "sleigh race" in which she prevailed in 2015.

The relevant question for a proud African-American community looking for her historic achievement to be more substantive than symbolic is: Can she win?

Since Toledo adopted the strong mayor form of government, only once has it reelected an incumbent mayor and in that sole instance it took a blooming Bill Clinton economy in 1997 and former mayor "Carty Finkbeiner running against an unknown tombstone salesman to produce a photo finish victory by a mere 700 votes," according to a political insider.

While a Hicks-Hudson victory is not impossible, there are several challenges which make the feat extremely difficult.

With Sherrod Brown likely running for reelection to the U.S. Senate and an open race for Ohio Governor also taking place in 2018, the Ohio Democratic Party is not likely to provide Hicks-Hudson with the financial and field support she received in the past which provided her with the competitive advantage needed to eclipse a crowded 2015 field of rivals.

However, it is the continuing structural decline in the city's economic vitality passed down from previous administrations that may provide the most serious threat to undermine the reelection efforts of the city's first African-American female mayor.

The voters will likely be evaluating Hicks-Hudson on her capability to manage an aging city with an aging population and a declining tax

base and where the State of Ohio has reduced funding earmarked for Toledo by \$83 million dollars over the past seven years.

These issues are, without a doubt, misfortunes. Yet, to be fair, missteps also have to be acknowledged.

The mayor has yet to parlay her previous victory into a relevant brand or message that will set her apart from any potential challengers in 2017. Although ProMedica's high profile relocation downtown is in motion, the Southwyck land deal is complete and there is possibly a new Metro Park on the horizon, these were all begun by her predecessors. There have not been any major accomplishments that she can solely hang her hat on.

Rebranding is mandatory if the mayor is to ward off competitors who see her vulnerabilities, as one political insider says, as being "in charge of a dysfunctional city and a government that doesn't work: the levy that couldn't pass, the potholes that can't get filled, putting a hiring freeze on your employees and yet giving people like Bob Reinbolt big raises."

The newspaper headlines that highlight city/county fights or say things like "City defaults on payment" or "City refuses to pay for criminal justice costs" are not helpful either.

From a social perspective, there is also an urgent need to keep the racial peace and improve police/community relations at a time when the ranks of black police officers and firefighters are at their lowest levels in several decades due to the retirement of cohorts hired under a federal court mandate originating in 1984.

Although Police Chief George Kral is very well respected, the mayor has appeared to de-emphasize race at a time when mistrust of police by communities of color exists.

"I actually can't believe that former chief Derrick Diggs was sort of driven out of town the way he was and how quickly he was embraced by a Florida community that I don't even know if he ever stepped foot in before he took the job, that speaks poorly of us. And I know there were personalities and politics involved, and I have nothing against Kral, but especially in this time in which we live, not even predating Black Lives Matter, but everything, it really...your police chief in an urban city is just a crucial person in terms of building trust and we had someone in Diggs who I think was the right kind of person to be a part of that," another political insider lamented.

Yet there are opportunities for success should Hicks-Hudson not change her mind and instead, according to rumors, seek judgeship for the Toledo Housing and Environmental Court (current Judge C. Allen McConnell will soon reach mandatory retirement age and some powerful Democrats are trying to convince Hicks-Hudson to become his replacement).

One opportunity is the 0.75 percent income tax renewal that will appear on the November 2016 ballot. Should the measure pass it will allow some financial flexibility for the city. The scary fact is that if it fails, Toledo could possibly go bankrupt leading to massive layoffs of safety forces and fiscal oversight.

Also, regional water is a major public policy opportunity as well as threat that must be addressed. A recent study has indicated that the suburbs could, for a very modest investment, develop their own new EPA

approved water plant. As a result, the suburban cities would have administrative control over their own water and no longer need to purchase it from Toledo. Should the suburban communities leave the current arrangement for one that has definite and direct financial benefit to them, the basic water rates for Toledo residents will increase 300 percent, a tremendous burden upon Toledo seniors, poor and people of color. Although the power dynamic has shifted from Toledo to the suburbs, our neighbors have expressed an interest in collaborating with Toledo should they be treated like investors rather than customers.

This is the tough social and economic landscape faced by our first African-American woman mayor. If she is to win reelection, there are multiple influences that make her political struggle an uphill journey.

Hicks-Hudson must not only be an astute manager, she must also lead.

Rep. Kaptur Applauds \$700 Million Retool of the Toledo Jeep North Assembly Plant

700 New American-Made Jobs for Next Generation Jeep Wrangler

Congresswoman Marcy Kaptur (OH-9) applauded last week's announcement by **Fiat Chrysler Automobiles** for their planned \$700 million investment in the Toledo Assembly Complex North Plant to produce the next generation Jeep Wrangler.

"This is almost beyond belief, given where we were eight short years ago," said Kaptur, the co-chair of the Congressional Auto Caucus who for the past eight years has spearheaded efforts to support the comeback of the US domestic automobile sector.

"This is the great American comeback story of this century, and it's a testament to the superb quality of the Jeep Wrangler, and the superb quality of the Toledo Assembly Complex frontline assembly workers, the plant management, the countless brilliant engineers, and its partnership with the United Auto Workers' Local 12. For 75 years Toledoans have manufactured Wranglers. FCA's investment today will ensure this legacy remains for years to come."

According to initial reports, the expansion of the North Plant will create 700 new jobs. An announcement regarding the future of the South plant is forthcoming. This production action is subject to the formal approval of incentives by state and local entities.

Kaptur continued: "The auto industry is the industrial backbone of Toledo, of northern Ohio, of the Midwest, and, frankly, the nation. Its recovery, which I was privileged to support and organized for legislatively, even when it was an unpopular position to take, is reflected in the six years of continued sales growth and increased revenue data. Slowly and surely, Toledo and northern Ohio's future is being reshaped and reinforced by announcements like the one FCA is making today. When given a fair chance, we will compete and we will win."

Second phase project will reduce energy consumption, utility costs

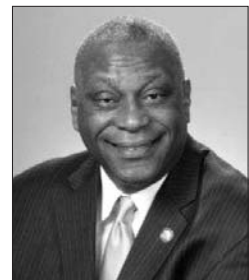

State Rep. Michael Ashford (D-Toledo) last week announced the release of \$1,448,700 in state dollars to University of Toledo (UT) for the Campus Energy Cost Reduction project. The second phase of the ongoing project includes installing digital controllers to new motion sensors and replacing old pneumatic thermostats with newer digital models. Together, the upgrades in energy systems will help the university reduce its energy consumption and utility costs while boosting air quality and allowing for better temperature regulation.

"Outdated energy systems mean money out the window that could otherwise be used to improve the learning environment for UT students," said Ashford. "Reducing energy waste and improving the classroom experience will position both the uni-

versity and its students for continued success."

The current UT energy systems, installed between 1950-1990, are now outdated and considered wasteful by today's energy standards. The Campus Energy Cost Reduction project consists of three phases aimed at reducing energy consumption and utility costs at UT. The first phase addressed lighting in University Hall, Wolfe Hall, Learning Resource Center, Collier Building, and Mulford Library.

Families are Tapping More Scholarships and Grants to Pay for College

Families spent less out-of-pocket for college in academic year 2015-16 compared to last year, as they took advantage of more scholarships and grants to foot the bill, according to "How America Pays for College 2016," the national study from Sallie Mae, the country's largest private student lender, and Ipsos, a global independent market research company.

Scholarships and grants covered 34 percent of college costs, according to the report, the largest percentage of any resource over the last five years. Approximately, half of families used a scholarship or grant to help pay for college.

"Families wrote smaller checks for college this year as they looked less to their wallets and more toward free money to make college happen," says Raymond Quinlan, chairman and chief executive officer, Sallie Mae, a company focused on helping families save, plan and pay for college. "Scholarships and grants have become an increasingly important part of the pay-for-college mix, and it's encouraging to see organizations, schools, and the gov-

ernment stepping up to provide them."

- Bachelor's: the new norm: Families are firmly in agreement on the value of college: 98 percent believe it's an investment in their student's future and 90 percent expect their student to earn a bachelor's degree. What's more, 54 percent of families expect their student to earn a graduate degree.

Families are putting their money where their mouth is -- the vast majority are willing to stretch financially to make college happen.

- Making college more affordable: Nearly all families took at least one cost-saving measure, while most took five or more. These measures include cutting personal spending, working while in school, living at home, and taking accelerated coursework to graduate faster.

Additionally, four in five students attended college in their home state, and one in three started at community college. Eighty-five percent of families completed the Free Application for Federal Student Aid (FAFSA).

- **Borrowing not a forgone conclusion:** Fewer than half of families borrowed last year. In fact, the proportions of funding from family savings and income and scholarships and grants were twice as high as the proportion of funds borrowed. Student borrowing paid 13 percent of all college costs, down from 16 percent last year.

- **Cost important, but not top factor:** Sixty-seven percent of families narrow college choices based on cost, but when it comes to making the final decision, this takes a back seat. Primary reasons in choosing a college are split evenly between academic program and personal choice, which includes campus culture, extracurricular activities and student population. Cost ranked third at 27 percent.

- **Planning still pays off:** Only 40 percent of families have a plan to pay for college — but in families with plans, students are more likely to pursue bachelor's degrees, there is more willingness and ability to spend on college, and students borrow 40 percent less than those from families without plans.

In addition to the plaque presented to Barbara Cobham, another will be placed in the boardroom to remind visitors of Cobham's contributions to the ongoing success of the financial institution he helped to create.

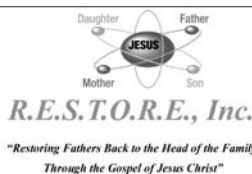

The Education of Kevin Powell by Kevin Powell

You never knew what you didn't have.

There were times in your childhood when cereal was supper because there was nothing else. When birthday toys seemed gently pre-loved, hand-me-downs were new to you, and you were none the wiser. Your family didn't have much and you never realized it then but in the book *The Education of Kevin Powell* by Kevin Powell, getting schooled later was rough.

Born in the spring of 1966, Kevin Powell entered the world and, though his mother had moved to Jersey City from "Down South" to escape it, slid directly into poverty. They shared a rat-and-roach-infested apartment with Powell's aunt and her son, and their *us-against-the-world* closeness was "something safe, something magical..."

At age four, Powell "did not know what the word 'drunk' meant," but he learned at a party, and was beaten by his mother for getting drunk-sick. At age six, his grandfather died, but although Powell barely knew the man, he understood that he was a wife-beater. At 13, he impulsively joined a fight and lost his cousin, who angrily shunned Powell for the rest of their lives.

As he grew and matured, Powell began to realize that his family was poor. His home turf was bleak and there were times when it seemed like a dead-end, but his mother told him that he needed an education to become something. She'd never hugged

him. He received no physical affection from her; in fact, she beat him regularly. She said he wasn't "gonna make it," but she got him a library card anyway. Books opened up his world, he hungered to read, and he decided that he wanted to be a writer.

But then life intervened.

Powell went to college, but his temper got him into trouble time and again. He joined a mosque, but left it just as quickly. He'd learned to hate white people, and that got him into trouble, too. He found success in the entertainment world, but he started to drink and commit petty crimes; he hit bottom, then hit it again... until a search for his lost past gave him what he needed.

Imagine, if you will, that you're in the ring with a pro-wrestler.

He picks you up, and slams you to the mat. Then he does it again. And again. That's what it's like to read *The Education of Kevin Powell*: a series of literary body-slams, over and over and over.

Part of that effect comes from Powell's style: there are times when he pulls out a sense of childlike innocence that'll make you chuckle uneasily. But beware – there are teeth behind the wide-eyed schtick, and his next memory gnashes them. In a way, that can be quite relentless – but it's also very interesting and oh-so-entertaining.

I thought for a minute that I wouldn't recommend this book (now out in paperback) but I ended up liking it a lot. It's an up-and-down journey with humor and strength, and if that's what you need, then *The Education of Kevin Powell* is what you should have.


